# 4. CCCCO Update

- Perkins reauthorization is being pushed back; pending approval by the Senate.
- Strong Workforce reporting is now in NOVA platform (Round 1 local share reporting due Dec 1, 2017).
- California Apprenticeship Initiative RFA was released with \$7 million in funding available. Application deadline is Nov 15, 2017.
- IEPI Extensions: Extended deadlines for both the Guided Pathways self-assessment (December 23, 2017) and multi-year work plan (March 30, 2018).

### 5. CCCAOE Update

- Fall 2017 conference was sold out with over 600 participants.
- CCCAOE Board will formalize Associate Regional VP position. This person will attend meetings, serve on committees, and assist with advocacy. More information will be released in January 2018. Tina Recalde is the point of contact for our region.

## 6. CCPT Update

- M. Smith and J. Patel met with SDCOE and United Way to discuss initiatives in our region.
- CCPT will provide a summary of metrics for our region in January. If anyone has a request to the specific type of information they would like to see, please contact them.

#### 7. SWP Regional Projects Update

- Career Pathways/Work-Based Learning
  - JFF is making progress on analysis of our region's career pathways systems. Preliminary findings include:
    - Strong CP infrastructure exists, but stronger connections across institutions would increase matriculation and support.
    - Network leadership capacities across site administrations are needed to move to an integrated pathways agenda.
    - Strong WBL components are largely dependent on history of employer/industry partnerships. Shared understanding of each partner's system can lead to clear value propositions for pathways work.
  - Next committee meeting will be held on 11.7.17 and will focus on the region's current CP systems/gaps.
- Employment Readiness/Job Placement Services

- o Two committee meetings have been held and preliminary finding include:
  - Interest in better connecting instruction and student services.
  - Varied regional interest in using some form of case management system.
  - Each college is unique in terms of its organizational structure, tools, and process.
  - Work-based learning is handled by various staff and faculty.
- Next committee meeting will be held 11.13.17 and will focus on system wide recommendations.

## Marketing:

- Civilian presented findings from the competitive situational analysis. Top-level findings include:
  - The development of soft skills and middle skills that are most in demand in SD/Imp Counties should be focus of career education marketing communications.
  - Marketing communication should focus on superior support services.
  - Communication of middle skills jobs should be tailored to key sectors.
  - High cost and diminished valued of education can be used to increase interest in career education.
  - Community colleges need to address increased capacity, matriculation concerns and time to complete.
- Virtual meeting will be held 11.16.17 to examine additional findings from the competitive analysis report.
- Next full committee meeting will be held on December 7, 2017. The consumer analysis will be presented at that time.
- Collaborative Program Innovation Projects:
  - Approved projects are in contracting phase
- Data/Research
  - Outcomes from initial committee meeting included creation of three project goals:
    - Develop a structure/ system for research process
    - Provide feedback/support for SWP funded projects
    - Work-group to review new/prospective research projects
  - Next meeting will be held 11.8.17
- All Projects
  - January meeting open to all interested stakeholders.   - All project consultants will present final recommendations to WDC, ROC, and SDICCCA members present at the regional retreat (scheduled for February 23, 2017).
  - Once final recommendations are made we will convene the consultants to determine how to best integrate all projects into a cohesive regional system.
