Minutes

1. Welcome and Introductions

2. Approve Minutes from 11.15.17 & 1.17.18

• Motion to approve by T. McGrath, second by M. Fritch. Unanimously approved.

3. Approval of Regional Projects

- The SWP recommendations from all three projects, Career Pathways and Work-based Learning, Employment Readiness & Job Placement, and Regional Marketing, were presented within the Guided Pathways model. Group feedback included the following:
 - Re-evaluating that the SWP metrics listed within the document are directly achievable by the recommendations. If not, they should not be included.
 - T. McGrath advocated for adding recommendations that enforced collaboration with business and industry in all relevant areas as this partnership will be increasingly important for our students; especially around employment readiness and job placement activities.
 - Suggestion to change "campus" to "colleges" throughout document in an effort to be more inclusive of the entire region; not just individual sites.
 - Adding a more focused recommendation for the regional executive leadership to encourage and support college's marketing efforts to make websites more student centric.
 - M. Smith suggested a pilot project to re-design one college website; S.
 Cooke stated that MiraCosta would be interested. The group wanted to
 ensure that funding would then be available all colleges in the region for
 the same purpose.
 - Emphasizing the integration of the importance of the student experience across all recommendations to ensure ease of college navigation and support for students.

- An updated version will be presented at the WDC Retreat on 2.23.18. Retreat attendees
 will work collaboratively to further clarify and develop the individual projects and
 framework around each larger project area. This feedback will be used to guide the
 creation of the 17/18 and 18/19 work plans.
- Data/Research: T. Ngo Bartel presented the draft labor market analysis. Key findings
 included significance and identification of top middle- skills jobs in our region, job
 openings demand, supply and gap, and regional recommendations. T. Ngo Bartel

5. Budget Update

- 2016-17 status: S. Cox presented the 16-17 budget and current expenditures. \$100,000 is currently unallocated and must be spent by 12.31.18.
- 2016-17 17% allocation \$1.9 million: M Smith presented a memo from the Chancellor's Office outlining the 17/18 Positive Incentive Strong Workforce Funds. - 2017-18 and 2018-19 budget development: M. Smith and S. Cox are working collaboratively to develop 17/18 and 18/19 Strong Workforce budget models based on the project recommendations. The 2017-18 budget is due 3.31 and will be presented at the next ROC meeting on 3.21.
