## T. Recalde called the meeting to order at 10:39am

- 1. Welcome/Introductions
- T. Recalde provided CCCAOE updates: Call for presentation is open and registration should begin around January 22. The theme is *Advocacy for Career Education: K-14 Strong Workforce*.
- 2. Approval of November 9, 2018 Minutes
  - Motion to approve by M. Fritch, second by J. Ayala, unanimously approved.
- 3. Programs recommended by Dean's Council
  - Southwestern College
    - o Drone Tech and Applications Certificate of Achievement
- 4. SWP Implementation Update
  - Implementation Workgroup Updates
    - Marketing: M Smith shared that Civilian will be working on native photos and getting ready for the new campaign launch in spring. The next marketing campaign update will be in February to ROC and in March to Deans/WDC.
    - Career Pathways: J. Patel reported that the region held a K12 SWP Engagement meeting on November 30 in San Diego County and on December 7 in Imperial County. There will be another committee meeting on January 23<sup>rd</sup> and it will be open to all stakeholders.
    - MS/HS Engagement: L. Wisdom shared that there are five new K12 representatives on the workgroup. The workgroup is finalizing documents that will assist LEAs in their K12 SWP applications. The documents that outline regional priorities contain career pathways goals, a pathway development rubric, MS/HS engagement goals, MS/HS career development continuum. These documents will be distributed via the SDIC listserv and regional consortium website.
    - Pathway Navigation: C. Estrada shared that the workgroup met on December 6. All RFAs will
      be received before the holiday break. Two positive themes have emerged, integration with
      Guided Pathways work and technology for intake processes. There will be a convening on
      February 25 for all PN RFA teams; it will be a platform to share best practices and continue
      discussion.
    - O WBL/JP: B. Gamboa informed that the WBL assessments are complete and results will be compiled and share in multiple venues in January. Regional and college level reports will be distributed to each college. One theme identified in the surveys was that WBL activities are being carried out in silos and there are pockets of success within career centers and classrooms. There will be a community of practice coming together around February. Most WBL RFAs have been received and most award letters will be sent out before the holiday break. The Job Placement RFAs have been funded and colleges are in varying stages of hiring. All positions will be in place by June 30, 2019. The JobSpeaker pilot is going well at all four colleges they are in the process of training and narrowing their use-case designs. Results of the pilot will help with regional coordination.
    - Tutoring: M. Romero reported that interviews occurred with workgroup members, CTE faculty, students, and tutors. The consultants are in survey development now and M. Romero will seek feedback from WDC.
    - Employer Engagement: C. Storey stated that she will have a sub-committee meeting with SDWP and SDREDC to discuss how to cross-refer clients across organizations and what the process will look like. The workgroup will meet again sometime in January.

- M. Smith introduced K. McMackin, the new Director of Strategic Partnerships employed by the Regional Consortium.
- O DSN Onboarding: M. Smith reported that four DSNs have been hired and there are two interviews pending for ICT and Advanced Manufacturing. The two remaining interviews will likely take place in December and January. It may be possible to have all six DSNs by January 23 onboarding date. A. Durham stated that since she is leaving her DSN role and will now be part of industry, she is willing to serve on an advisory committee. She was recognized for the great work she has done in the Health Care sector over the past 13 years.

# 5. K-12 Component of SWP

M. - o \$14.7M allocation. There was \$164M allocated to California's K12 system and linked directly to the SWP and the region received \$14.7M.
- Regional priorities documents include: Career pathways goals, pathway development, MS/HS engagement goals, MS/HS career development. The Career Pathways workgroup voted to request that 25% committed to each of the three areas of focus: pathway development, MS engagement, HS engagement. - Letter of Intent is available now through January 4
- Selection committee guidance will be coming out on the CCCCO website and the application for the Selection Committee should be available on the CCCCO website on Monday, December 17, 2018
- o The online application form for Pathway Improvement will come out January 7
